	<p>All concerned with the Event must follow the SRO Covid-19 Safety Protocol at all times and obey the instructions given at the event.</p> <p>Due to local noise restrictions, with the mandatory end of track activities at 19.00, no additional time can be granted to any series in case of a red flag during qualifying.</p>
Due to the space available in the pit lane, the following changes will be made to the 2021 Sporting Regulations for this event:	
Article 21	In accordance with Article 21 of the Sporting Regulations, the number of cars allowed to enter the Zandvoort round will be restricted to a maximum of 42 cars. Consequently, race-by-race entries will only be accepted from Entrants who have other cars already entered on a full-season basis. The selection of such race-by-race entries will be considered in order of receipt.
Article 20.1 a)	See Sporting Note #1
Articles 34.15 and 41.3	<p>Because of the number of cars and the limited space in the pitlane, for safety reasons, the following procedure will be implemented at the start of all sessions:</p> <p>At the beginning of a session, the fast lane may not be used until the green pit exit light is on. When the pit exit light goes green at the start of the session, cars must leave their 45-degree nose-out position one-by-one, starting with the car closest to the pitlane exit. Only if a car is clearly not leaving at the foreseen moment, the next car may leave its position to proceed to the pit exit. Any car which is clearly delayed</p>

	must remain in place until all other cars have left the pit lane and may then proceed to leave.
Pre-Grid	Please note that cars will be placed in their pit lane positions during the pre-grid procedures, in order to make it easier to move into the pit lane.
Paid Testing	There will be an official paid test on Thursday June 17th in accordance with article 30.3 of the 2021 Sporting Regulations
